

# Frequently asked questions

#### Is there a fee to attend?

Community Care Live is offered free of charge to all registered social workers, local authority social care senior managers, commissioners or workforce leads, government ministers or senior civil servants, police officers, youth offending service staff, probation officers and final-year social work students.

Individuals who do not meet this criteria but would still like to attend will be required to pay the event delegate fee of £395 + VAT, during the online registration process or on site (payable by credit or debit card only).

In addition to our free seminar programme, our legal learning sessions carry a fee of £30+ VAT if booked online or £40+VAT if you pay at the registration desk during the event days.

#### Can I pay by invoice for legal learning sessions?

No, payment is strictly by debit or credit card only.

#### I am a student; can I visit the event?

Free attendance is available for ALL social work and occupational therapy degree students and those in higher levels of education. Students in any other area of study will be required to pay the conference delegate fee.

The Government's decision not to implement Liberty Protection Safeguards for the foreseeable future means it is important to refocus on the Deprivation of Liberty Safeguards (DoLS). ## **Oasis Restore**

#### Be part of the revolution!

Oasis Restore is the UK's first secure school and is at the forefront of a long-awaited revolution in youth justice. Our school offers therapeutic, integrated, and bespoke support for children, along with pathways for successful transition that equips them to contribute to a safer community. The secure school is an alternative to custody for children aged 12-19, therefore all children living with us at Oasis Restore will be sentenced or remanded into youth custody by the courts, and would otherwise be placed in young offenders' institutions, secure training centres or secure children's homes.

Through our cornerstones of Relationships, Community and Discovery we will offer children a home, education and community that is driven by their needs and safety. Children will live in small flats ranging from 2-6 bedroom, they will attend school every day, alongside access to the appendix support and be provided with opportunities to engage in activities they enjoy and discover new talents and passions.

Our homes, school, and overall environment has been designed with children at the centre. We have been supported by experts as well as children and adults with experience of custody to design our school and homes in a way that allows children to thrive. For example, we have barless windows that open and doors which when closed, don't slam.

Safeguarding at Oasis Restore is embedded in everything we do; our practice model is designed to create an environment of safety through intentional and aspirational care and education. Where relationships and building a home/ community is at the heart of who we are and our practice, where we listen to our children and work with them to build trust, create safety and provide opportunities.

Children and staff have access to therapeutic intervention to discover themselves and process their experiences alongside opportunities to experience restorative forgiveness. Our aim is for children to value their time at Oasis Restore, to enjoy learning, and to leave ready to contribute to society. We acknowledge that traumatic early life experiences, adversity and exploitation negatively affect the children we serve and those around them, including the victims of their crimes.

Young people placed at the secure school will need to come to terms with the consequences of their criminal behaviour: the sentence is their punishment. Our job is to listen and understand the stories behind those actions, to support them to start making amends in whatever ways they can, and to help them build the skills they need for a positive future.

It remains vigilant about safeguarding when allegations of domestic abuse arise and these are explored carefully. I left the day feeling both completely knackered and genuinely in awe of the work that social workers do every day.


